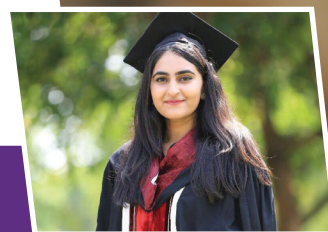
We keep it small

Why BA-LL.B?

The BA-LL.B is designed for students seeking a challenging, rigorous, interdisciplinary exposure to law and related vital disciplines. Whilst the focal point of the programme is the Pakistani legal system, the teaching methodology encompasses a critical, comparative approach in order to promote a deeper understanding of the law: the ambit of the study and analysis is not just laws as they exist and operate, but also how policy impacts laws, and how law, policy and society interacts.

THE PROGRAMME

The BA-LL.B programme is split into two parts. In the first two years of the BA phase, students are introduced to a wide range of subjects offered by other Schools at LUMS. During this stage of their studies, law students are exposed to concepts and ideas taken from other relevant disciplines such as history, political science and psychology, and are equipped with vital communications and analytical skills.

The LL.B phase consists of a number of core law subjects as prescribed by the Pakistan Bar Council, supplemented by a wide range of topical elective courses on specialist areas of law as well as practical skills courses, such as Moot Court and Legal Aid Clinic. Law students are expected to undertake summer internships at law firms, NGOs and courts.

OUTSTANDING CAREER OPPORTUNITIES

- SAHSOL graduates go on to pursue successful careers in the legal profession both in Pakistan and overseas
- Our graduates have exciting and varied careers in academia, NGOs, financial institutions and are successful in other areas including the private sector, civil bureaucracy and regulatory, research and policy making bodies
- Over 85% of the graduating class of 2017 is already employed or continuing their studies

STATE-OF-THE-ART FACILITIES

- SAHSOL is home to a dedicated Moot Court, a reading room, discussion rooms and several lecture theatres

- The Gad and Birgit Rausing Library at LUMS has an extensive law collection consisting of 35,000 print volumes, 25,000 e-books, over 1100 e-journals, 22 local and foreign law journals, as well as subscriptions to 35 databases including LexisNexis Academic, Westlaw India and the Pakistan Law Site
